Full Membership requires the payment of a one hundred dollar (\$100) non-refundable Application Fee, the purchase of a three hundred dollar (\$300) membership certificate / bond (refundable upon termination of membership in accordance with the bylaws) and the payment of annual family dues, fees and assessments applicable to the operating season. The Refundable Membership Certificate purchase may be made over a period of not more than three (3) years. See "Levels of Membership" below.
2. Annual dues and due date, as established by the Board of Directors, must be paid in full before annual membership privileges are granted. A "late fee" will be assessed against payments made after the established deadline. Failure to pay annual dues obligations in full will result in reduction or forfeiture of Membership Certificate value and membership rights and privileges.
3. Membership is non-transferable.
4. Resignation from KESC membership must be submitted in writing and postmarked no later than June 1<sup>st</sup> of the current membership year to avoid a waver charge being assessed to the value of the membership certificate.
5. All KESC members must be cognizant of and abide by the club rules and regulations. Copies of the KESC Rules and Regulations and the KESC Bylaws are available from the Board of Directors or the club managers.

Year #1 - (\$100 Non-refundable Application Fee + \$150 Half Membership Certificate / Bond payment + Annual Dues)  
Year #2 - (\$150 Half Membership Certificate / Bond payment + Annual Dues)  
Year #3, 4, 5, etc. - (Annual Dues only)

**"C" MEMBERSHIP - PARTIAL MEMBERSHIP PRIVILEGES (see note). This is a one-time only trial membership option. Membership must be converted to an "A" or "B" Membership in Year #2**

Year #1 - (\$100 Non-refundable Application Fee + Annual Dues (pro-rated after 2<sup>nd</sup> week))

Conversion of "C" Membership to "A" Membership:

Year #2 - (\$300 Full Membership Certificate / Bond payment + Annual Dues)  
Year #3, 4, 5, etc. - (Annual Dues only)

Conversion of "C" Membership to "B" Membership with conversion to "A" Membership in Year 3:

Year #2 - (\$150 Half Membership Certificate / Bond payment + Annual Dues)  
Year #3 - (\$150 Half Membership Certificate / Bond payment + Annual Dues)
